Definition of a Session

A session is defined as the call up of your specific BusinessMap24 Easy URL. Every call up of the URL is counted. You will receive a daily updated statistic on your used sessions in the user administration area.

Hosting of Location Data

The session-based BusinessMap24 Easy lets you store up to 100 locations on the Map24 server for free. It is possible to conduct proximity searches, as the locations are stored on the Map24 server. Additional locations can be stored on the Map24 servers in blocks of 2,000. The price for each block is EUR 500.00 and is invoiced on a onetime only basis.

Payment Methods

Invoices can be settled by credit card or bank transfer. Electronic transfer is only available in Germany. Unused sessions expire after 24 months. If your session credit runs out, your account will be suspended. Every customer is informed as part of the regular email contact before the limit of credit is reached. If you agree to automatic top-up, your second and subsequent session purchases will attract a 5% discount.

The herewith offered functions are only relevant to end user use on freely accessible websites. The usage of Map24 services on domains or web applications that require a registration are in a password protected area, or where usage is limited to a certain audience in any other way, is prohibited. Use of Map24 services for call centers or similar internal uses is not part of this offer. Transfer and/or display of data, which relate to measuring of automotive- or personnel movements or their location finding based on technical systems such as Global Positioning Systems (GPS), gyroscopes, wheel sensors, etc., are not permitted. A separate license is required for this.
